

AMENDMENT # 1 TO AGREEMENT FOR PROFESSIONAL SERVICES
BETWEEN
THE TRANSPORTATION AGENCY FOR MONTEREY COUNTY
AND
GHD, Inc.

THIS AMENDMENT NO. 1 to the agreement dated January 23, 2019, between the Transportation Agency for Monterey County, hereinafter referred to as "TAMC," and GHD, Inc., hereinafter referred to as "Consultant," is hereby entered into between TAMC and the Consultant.

RECITALS:

- A. **WHEREAS**, TAMC and Consultant entered into an agreement for professional engineering services for On-Call Roundabout Design Peer Review on January 23, 2019, hereinafter referred to as "Agreement;" and
- B. **WHEREAS**, additional outreach work is needed for the SR 68 Scenic Corridor task order relating to the roundabout alternatives; and
- C. **WHEREAS**, Caltrans and TAMC have jointly prepared and submitted a BUILD Grant application to construct the SR 156 Widening Project task order, which required time-sensitive traffic forecasting and grant application support for roundabout solutions; and
- D. **WHEREAS**, TAMC and Consultant desire to amend the Agreement by revising the Scope of Services and increasing the total amount of compensation, in order to meet the demands of the State BUILD Grant, and maintain the schedules of the task orders for the SR 68 Scenic Corridor and SR 156/Castroville Blvd. projects.

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. TERM OF AGREEMENT

The term of this agreement will remain the same, terminating on January 31, 2022. The effective date of this Amendment is August 26, 2020.

2. TOTAL COMPENSATION

The total compensation to be paid pursuant to this Agreement as amended shall be increased by One Hundred Sixteen Thousand Dollars (\$116,000), and the total contract shall not exceed Seven Hundred Fifty-six Thousand Dollars (\$756,000).

All references to the amount \$640,000 shall be replaced with the amount \$756,000. Exhibit B (Budget) shall be replaced with Exhibit B1, attached hereto and incorporated into the amended Agreement as fully set forth therein.

3. **SCOPE OF SERVICES**

The Scope of Services attached to the Agreement as Exhibit A is hereby amended to include the additional services, as shown in Exhibit A1, and attached hereto.

4. **REMAINDER OF TERMS UNCHANGED**

All other terms of the Agreement remain in full effect.

An executed copy of this Amendment No. 1 shall be attached to the Agreement and shall be incorporated as if fully set forth therein.
